Dear Wayne:

Thank you for providing the IHEA an opportunity to field test the Waynes Wicked Rifle Reel and Barrel Bumper Muzzle Protector. As I mentioned when you contacted me asking for a product test, I reside in Colorado where the use of tree stands is uncommon for rifle hunters. With that in mind, I sent the Rifle Reel/Barrel Bumper sample along with the instructional DVD to the hunter education administrator in South Carolina for field testing. I know they hunt from tree stands in South Carolina; therefore I was certain that the Rifle Reel/Barrel Bumper could be adequately tested in a tree stand hunting environment. South Carolina's hunter education administrator gave the Rifle Reel and Muzzle Protector to one of his master instructors and asked that the instructor provide an evaluation.

As I explained (warned) to you, when I receive any type of product to test, I or the person testing the product for me will provide an honest assessment. If the product is inferior or fails, we will not "pull any punches" and we'll let you know. Likewise, if the product works well and adds to the safety of a hunt, we'll let you know that too.

The IHEA does not endorse any product, but we certainly let our members know what products work well and which products should be returned to the design department. Our administrators don't hesitate to share product evaluation information with their respective 70,000 instructors.

With that in mind, here is a synopsis of the Rifle Reel/Barrel Bumper field evaluation from the South Carolina Master Hunter Education instructor. (All comments are unedited quotes.)

- ✓ **"First the Rifle Reel is a great item to have on any gun. I installed it on my Winchester M70 Sporter Rifle and loved it."**
- ✓ **"I liked the way that the strap was reeled back in leaving nothing hanging thus I didn't see the need to remove it while in the stand."**
